Additionally, he gained extensive experience through various roles, including Senior Executive Officer at the Office of the Cultural and Sports Secretary to the President, Specially Appointed Professor to the School of Cyber Security of Korea University, and Dispatched Student to the Korea National Defense University's Security Program.

Mr. Oh graduated from Seoul National University in 1988 with a bachelor's degree in geography, received a master's degree in arts management from the University of Oregon in 2004, and a doctorate in engineering from Korea University in 2012. Since his retirement from the Ministry of Culture, Sports and Tourism in 2022, Mr. Oh has served as a Specially Appointed Professor at the School of Cyber Security of Korea University, and joined Shin & Kim in May 2025.
