**Mr. Sinseob Kang is a senior counsel of Shin & Kim. Mr. Kang's practice focuses on litigation involving securities, derivative products, real estate, real estate investment trusts and project finance.**

Mr. Kang's key work includes the J.P.Morgan financial derivatives litigation against Korean financial institutions; the beneficiary certificate redemption litigation regarding Daewoo bonds; finance-related litigation between Korean securities companies and Korean banks; and litigation involving trust companies and trustors. Mr. Kang is also credited with the establishment of the first judicial precedent on trust companies' legal responsibility for development trusts.

Prior to entering private practice, Mr. Kang served 12 years in the Korean judiciary, as a judge of the Seoul District Court in 1986 and as a research judge of the Supreme Court of Korea. He has also taught civil law as an adjunct professor at the Judicial Research and Training Institute and was a member of the Policy Committee of the Ministry of Justice and the Dispute Settlement Committee of the Financial Supervisory Service. He also serves as an outside director for several listed and non-listed companies, as well as an advisor to various state owned enterprises. He was recently named Managing Partner of the Year at the 2014 ALB Korea Law Awards.
