In particular, Mr. Han intensively handled various economy-related cases in connection with corporate and/or financial affairs while serving as chief judge of the single criminal justice division of the Seoul Central District Court exclusively in charge of economy-related cases and cases on infringements of business secrets and as chief judge of the civil settlement division of the Seoul Central District Court exclusively in charge of corporate cases and carved out a brilliant judicial career not only in civil/commercial litigation but also in criminal justice as he served as judge of a division exclusively in charge of appeal cases, including those on provisional disposition, and a civil division of the Seoul High Court and as chief judge exclusively in charge of warrant-related affairs and chief judge of a single criminal justice division of the Pohang Branch of the Daegu District Court.
