For three years from 2017, he served as Chairman & CEO of the Korea Exchange, where he strived to revitalize the capital market so that promising companies with technology and potential growth could successfully list on the KOSDAQ market. For three years from 2020, he served as Chairman & CEO of the General Insurance Association of Korea, where he was involved in the amendment of the Insurance Business Act for simplified (computerized) medical indemnity insurance claims, and contributed significantly to the development of the non-life insurance industry through deregulation and the identification of new growth engines.

Mr. Jung has accumulated extensive experience and expertise in the field of banking, securities, and insurance in both the public and private sectors over the past 38 years.
